






## ABOUT AUSTRALIA

- Work Experience documents (Appointment letter, Pay Slip & salary Statement)

- Copy of Passport Front and last page
- Statement of Purpose (if Gap or required by the university for admission)

- Living Expense- 29710 AUD

- Travel Expense- 2000 AUD
- Over Seas Health Cover (oshc)- 2000 AUD




## GTE CHECKLIST:

- Signed offer letter.
- Any additional documents as part of the condition on the offer letter
- Affidavit of support from parents/sponsor
- Identity proof of all sponsors and relation proof (Aadhaar Card & PAN Card)
- Last 3 Years ITR's with computation sheet or Form 16 for all sponsors
- Source of Income for all sponsors
  - a) If salaried – Letter from employer, Last 3 months' salary slips, and bank statements reflecting salary credits.
  - b) If business – Proof of business registration (mandatory), current account statement (if applicable)
  - c) Agricultural Income – Proof of agriculture land in Govt. records (Farad etc.), Current market value from Govt. authority, Certificate for agriculture income depending on land and sales proceeds from Tehsildar or Sub Divisional Magistrate, Income Tax Returns
- Savings Bank Statement – Last 3 to 6 months' bank statement with updated transactions along with visiting card of a bank manager
- Fixed Deposits – Copy of fixed deposit advice letter and balance certificate issued from the bank along with visiting card of a bank manager.
- Acceptable source of funds in case of recent deposits.
- Education Loan (If Applicable)
  - a) Loan sanction letter
  - b) Evaluation Reports against which the loan has been issued.  
(Education loan sanction letter must include – Details of course, Tuition fees, Rate of interest, repayment plan, and security)
